### Substantiations:

- ASO:** Does not contain active substances, and affects rodents (or insects) physically, catching them with the glue trap: ([1] - I. General questions).
- ASF:** Although rodents (or insects) are lured into the glue trap with the help of aroma, excreted from the glue layer, the products should not be regarded as attractants, because the origin of the aroma is food product type, which should not be regarded as active substance: ([1] - Annex 1; [4]).
- DSO:** Products do not contain substances, which according to Directive 67/548/EEC are classified as hazardous for human health or environment, substances which are Persistent, Bioaccumulative and Toxic (PBT) or very Persistent and very Bioaccumulative (vPvB): ([2] - Article 31, clause 1 and 3).
- OELO:** Products do not contain substances, for which there are Community workplace exposure limits: ([2] - Article 31, clause 3; in Latvia: according to [3]).
